Pursuant to Regulation 30 (6) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Para A of Part A of Schedule III of the said regulations, The Board of Directors at their meeting held on 7th Feb, 2023, have inter-alia, considered the following:

- 1. To Borrow funds from the Energy Access Relief Fund B.V. (EARF) managed by Social Investment Managers and Advisors, LLC upto USD 2.5 Million (amounting approx. Rs. 20.7 Crore) in two tranches to facilitate the manufacturing activity and modernization of our Company and its wholly owned subsidiary namely Insolation Green Energy Pvt. Ltd. The said borrowings will bear an annual interest of 5% USD and will mature on July 15, 2025.
- 2. On recommendation of Nomination & Remuneration committee, the Board of Directors of the Company has appointed Ms. Ankita Sen, as Company Secretary and Compliance Officer of the Company with effect from 7th Feb, 2023.
